REFUNDS

Bright Education Pty Ltd (hereafter known as Bright Education or The Company) will ensure that a full refund of enrolment fees will be made if a course is cancelled by The Company. An application for refund of course fees under any other circumstance, must be made to us in writing.

An eighty percent (80%) refund is available up to ten working days prior to the commencement of the training program. Cancellation of enrolment under these circumstances will incur a twenty percent (20%) administration fee.

A fifty percent (50%) refund is available for cancellations that are five to ten working days prior to the commencement of the training program. Cancellation of enrolment under these circumstances will incur a fifty percent (50%) administration fee.

No refund is available where cancellation is made less than five (5) working days prior to the commencement of a course, or to participants who do not attend the entire course. Participants cancelling prior to course commencement have the opportunity to defer their enrolment to an identical course schedule within six months of the original course, without financial penalty.

A minimum of two (2) business days' notice must be provided for any deferral.

Refunds will be considered on a pro-rata basis for participants who fall ill or are injured to the extent that they can no longer undertake the course, providing a supporting Medical Certificate is supplied to us.
