## Mandatory Questionnaire for travel to sites for Bright Group Employees

The following pre-entry questionnaire **must** be completed for all travel to mine sites by Bright employees.

**All international arrivals** to Australia are still required to self-isolate for a period of 14 days. As this is a legally enforceable requirement, if you have returned from overseas, **please do not attempt to return to site or to the Bright Group Head Office until you have completed your 14-day isolation period.**

If you are experiencing any flu like symptoms, regardless of your travel history, **do not travel to site.** Get in touch with your GP and Bright Group contact before returning to any Bright Group sites or office. This includes post-recovery from the flu – do not return to work until you are fully recovered from all flu symptoms.

**Employees travelling to site for the major mining companies - please familiarise yourself with the client site containment measures and adhere to travel screening procedures. Interstate employees are required to familiarise themselves with the WA border controls and the border controls of their respective states.
